SUBJECT: PUBLIC HEARING TO CONSIDER MODIFICATIONS TO THE COLORS ON THE EAST ELEVATION OF BUILDING 1 OF TAM RIDGE RESIDENCES.

NOTICE IS HEREBY GIVEN that the Corte Madera Planning Commission will hold a public hearing on August 23, 2016, to consider proposed modifications to the colors of the east elevation of Building 1 of Tam Ridge Residences, also known as “Wincup.” The east elevation of Building 1 faces Nellen Avenue and Highway 101. This hearing continues previous discussion regarding this item from the joint Planning Commission/Town Council meeting held on April 19, 2016. No other aspect of the project will be discussed at this hearing.

The Planning Department has determined that the permit amendment is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15061(b)(3) since it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment.

All persons interested in the foregoing are invited to appear before the Corte Madera Planning Commission at the time, day and place mentioned above. Staff reports are usually available by 4:30 p.m. on the Friday before the meeting and may be obtained from the Planning Department, Corte Madera Town Hall, 300 Tamalpais Drive, Corte Madera. If you challenge this project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this NOTICE, or in written correspondence delivered to the Town of Corte Madera at, or prior to, the public hearing. All written correspondence will become part of the public record.
