

RESOLUTION NO. 05/2014

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CORTE MADERA
AMENDING RESOLUTION NO. 3242 BY RESCINDING THE PAYING AND
REPORTING THE VALUE OF EMPLOYER PAID MEMBER CONTRIBUTIONS
(EPMC) FOR CONFIDENTIAL, PROFESSIONAL/TECHNICAL, AND
MID-MANAGEMENT EMPLOYEES EFFECTIVE WITH THE PAY PERIOD
02/03/14 – 02/16/14

WHEREAS, the Town Council of the Town of Corte Madera adopted Resolution No. 3242 on June 4, 2002 which Authorized the Paying and Reporting the Value of Employer Paid Member Contributions (EPMC) for Confidential, Professional/Technical, Mid-Management, and Department Head Employees Commencing June 10, 2002; and

WHEREAS, the Town Council of the Town of Corte Madera adopted Resolution No. 3698 on February 21, 2012 which Repealed the Paying and Reporting the Value of Employer Paid Member Contributions (EPMC) for Department Head Employees Commencing March 5, 2012; and

WHEREAS, the Town Council of the Town of Corte Madera has adopted Resolution No. 04/2014, a Resolution Fixing Compensation and Establishing Certain Benefits for Confidential, Professional/Technical, and Mid-Management Employees of the Town of Corte Madera.

NOW, THEREFORE, BE IT RESOLVED pursuant to Section 13 of Resolution No. 04/2014, effective with the pay period 02/03/14 - 02/16/14, EPMC pursuant to Resolution No. 3242 for Confidential, Professional/Technical, and Mid-Management Employees is hereby repealed.

BE IT FURTHER RESOLVED that effective with the pay period 02/03/14 – 02/16/14, Confidential, Professional/Technical, and Mid-Management Employees covered by the provisions of Resolution No. 04/2014 shall have the Town pay their member contributions in accordance with Resolution No. 2307, a Resolution Implementing “EMPLOYER PICKUP” of Member Contributions to the Public Employees’ Retirement System, (Section 414(h)(2) Internal Revenue Code), adopted by the Town Council on February 4, 1986, as set forth in Section 13 of Resolution No. 04/2014.
