

**RESOLUTION NO. 22/2014**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CORTE MADERA  
FIXING THE EMPLOYER’S CONTRIBUTION UNDER THE  
PUBLIC EMPLOYEES’ MEDICAL AND HOSPITAL CARE ACT**

**WHEREAS,** (1) Government Code Section 22892(a) provides that a local agency contracting under the Public Employees’ Medical and Hospital Care Act shall fix the amount of the employer’s contribution to an amount not less than the amount required under Section 22892(b) of the Act, and

**WHEREAS,** (2) The Town of Corte Madera is a local agency contracting under the Act; now, therefore be it

**RESOLVED,** (a) That the employer’s contribution for each employee or annuitant shall be the amount necessary to pay the full cost of his/her enrollment, including the enrollment of family members, in a health benefits plan up to a maximum of:

Plus administrative fees and Contingency Fund Assessments; and be it further

**RESOLVED,** (b) That the Town of Corte Madera has fully complied with any and all applicable provisions of Government Code Section 7507 in electing the benefits set forth above; and be it further

**RESOLVED,** (c) This resolution shall be effective January 1, 2015.

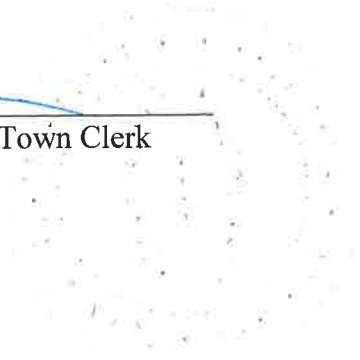
