

RESOLUTION NO. 03/2013

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CORTE MADERA ENDORSING SPARK (LARKSPUR-CORTE MADERA SCHOOLS FOUNDATION) AND ALLOWING A TEMPORARY BANNER SIGN IN THE PUBLIC RIGHT-OF-WAY FROM MARCH 6, 2013 TO MARCH 20, 2013 ADVERTISING THE SPARK FASHION SHOW ON MARCH 22, 2013

WHEREAS, on February 25, 2013, SPARK (Larkspur-Corte Madera Schools Foundation) to place one temporary banner sign in the public right-of-way on Redwood Ave. at Montecito Dr. south of the bus shelter from March 6, 2013 to March 20, 2013 advertising the SPARK Fashion Show on March 22, 2013; and

WHEREAS, SPARK has requested that the Corte Madera Town Council endorse the SPARK Fashion Show; and,

WHEREAS, Corte Madera Municipal Code Section 18.22.050(10)(A) permits such signs with the approval to the Town Council.

NOW, THEREFORE, BE IT RESOLVED, that the Corte Madera Town Council does hereby approve SPARK's request to endorse the SPARK Fashion Show and approves the request to install a 3' by 5' temporary banner sign as shown in Attachment A in the public right-of-way on Redwood Ave. at Montecito Dr. south of the bus shelter, subject to the following conditions:

1. The banner sign is permitted to be displayed from March 6, 2013 to March 20, 2013.
2. The applicant will pay a \$100 cost recovery fee to the Planning Department for staff time required to install and remove the removable hardware and the horizontal banner.
3. The applicant shall coordinate with Kevin Kramer, Director of Field Maintenance and Operations, to install and remove the removable hardware and the horizontal banner.


CALIFORNIA ENVIRONMENTAL QUALITY ACT("CEQA") DETERMINATION
