

RESOLUTION NO. 3698

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CORTE MADERA AMENDING RESOLUTION NO. 3242 BY RESCINDING THE PAYING AND REPORTING THE VALUE OF EMPLOYER PAID MEMBER CONTRIBUTIONS (EPMC) FOR DEPARTMENT HEAD EMPLOYEES AND THE TOWN MANAGER EFFECTIVE WITH THE PAY PERIOD 03/05/12 – 03/18/12 AND RESCINDING RESOLUTION NO. 3252 WHICH AUTHORIZED THE PAYING AND REPORTING THE VALUE OF EMPLOYER PAID MEMBER CONTRIBUTIONS (EPMC) FOR THE TOWN MANAGER

WHEREAS, the Town Council of the Town of Corte Madera adopted Resolution No. 3242 on June 4, 2002 which Authorized the Paying and Reporting the Value of Employer Paid Member Contributions (EPMC) for Confidential, Professional/Technical, Mid-Management, and Department Head Employees Commencing June 10, 2002; and

WHEREAS, the Town Council of the Town of Corte Madera adopted Resolution No. 3252 on August 6, 2002 which Authorized the Paying and Reporting the Value of Employer Paid Member Contributions (EPMC) for the Town Manager Commencing June 24, 2002; and

WHEREAS, the Town Council of the Town of Corte Madera has adopted Resolution No. 3697, a Resolution Fixing Compensation and Establishing Certain Benefits for Department Head Employees of the Town of Corte Madera and Amending Applicable Sections of the Town Manager's First Restated and Amended Employment Agreement Effective December 17, 2007, said Resolution No. 3697 Commencing July 11, 2011 and ending July 5, 2015.

NOW, THEREFORE, BE IT RESOLVED pursuant to Section 5 of Resolution No. 3697, effective with the pay period 03/05/12-03/18/12, EPMC pursuant to Resolutions No. 3242 and No. 3252 for Department Head Employees and the Town Manager is hereby repealed and Resolution No. 3252 is also hereby repealed.

BE IT FURTHER RESOLVED that effective with the pay period 03/05/12-03/18/12, employees covered by the provisions of Resolution No. 3697 shall have the Town pay their member contributions in accordance with Resolution No. 2307, a Resolution Implementing "EMPLOYER PICKUP" of Member Contributions to the Public Employees' Retirement System, (Section 414(h)(2) Internal Revenue Code), adopted by the Town Council on February 4, 1986, as set forth in Section 5 of Resolution No. 3697.
