On Tuesday, February 3, 2015 at 7:30pm at Corte Madera Town Hall, the Corte Madera Town Council will hold a public meeting to hear a staff presentation on the 2015-2023 Draft Housing Element, ask questions, recommend possible revisions, and consider forwarding the draft on to the California Department of Housing and Community Development (HCD).

This public meeting will provide an opportunity to ask questions and better understand the content of the draft document, the 2015-2023 Housing Element process, the overall timeline, and provide comments and input on the draft itself. An additional meeting before the Town Council is tentatively scheduled for February 17th, 2015, and would provide similar opportunity for public involvement and input.
