



IMPORTANT MEETING NOTICE

Project Homekey Proposal (1591 Casa Buena Drive)

The Town of Corte Madera would like to make you aware of two upcoming meetings regarding the proposed conversion of the motel at 1591 Casa Buena Drive (formerly the America's Best Value Inn) to supportive housing for individuals experiencing homelessness.

- **Corte Madera Town Council: Monday, November 2, 2020 at 6:30pm**
- **Marin County Board of Supervisors: Tuesday, November 10, 2020, 9:00am**

The County of Marin is considering purchasing the motel formerly known as the America's Best Value Inn (1591 Casa Buena Drive) with grant funding through Project Homekey and other County housing program funds for the purpose of providing 18 units of permanent supportive housing for individuals experiencing homelessness. While this is not a Town project, and the Town does not have jurisdiction over sale of a private property, Town staff is facilitating public discussion related to the program and proposed purchase. **Please see the below resources regarding how to obtain additional information and how to get involved.**

The Council will have the opportunity to publicly make any statement about this project and/or discuss any concerns they may have after hearing an update from staff and public comment. The Council will then have the opportunity provide feedback to the Board of Supervisors prior to any decision making by the County. The Marin County Board of Supervisors heard this item at their meeting on October 20th and voted to adopt a resolution issuing a notice of intent to purchase the motel site at 1591 Casa Buena Drive.
