TOWNHOME PROPOSAL FOR A 46-UNIT RESIDENTIAL TOWNHOME PROJECT. THE PROJECT SPONSOR WILL BE PRESENT TO DISCUSS ITS PROPOSAL AND

ANSWER QUESTIONS.

On Wednesday, April 22, 2015 at 7:30pm at the Corte Madera Recreation Center, the Corte Madera Planning Commission will hold Special Meeting to conduct an informational study session to review information related to the proposed 1441 Casa Buena Townhomes project and related land use applications. This meeting is intended to provide the Planning Commission and the public with an informal opportunity to better understand the necessary Town approvals associated with the proposed project, the upcoming land use process, and the applicant's objectives in the redevelopment of the project site from its existing use – a 32-unit, four building apartment complex – to a new 46-unit townhome project. The applicant will also present information about the project's design, massing, and site plan.

The Planning Commission will not take any actions or make any decisions at this meeting. Public comment will be limited to questions about the information presented at or prior to the meeting or other questions related to the 1441 Casa Buena Townhome project intended to help facilitate thoughtful consideration of the proposal. Future public meetings to formally review the applications and the environmental review documents will be held in the upcoming months. Comments about the merits of the proposal should be made at that time.

The proposed 1441 Casa Buena Townhome Project seeks to redevelop the existing 32-unit, approximately 28,000 square foot, four building, Cortebella apartment complex with a new 46-unit, approximately 104,000 square foot, 20 building townhome project, including eight homes for moderate and low income residents. The new residential units would be predominantly two-stories in height with some three-story elements, and would be a maximum 30 feet tall. The proposed project would comply with all of the development standards of the R-2 zoning district.

Background: The Community Facilities District was established by the Central Marin Police Authority under the Mello-Roos Community Facilities Act of 1982 pursuant to (i) a resolution adopted by the Police Council on August 6, 2008, following a public hearing and (ii) an election held on November 4, 2008 at which 69.32% of the 12,188 then qualified electors of the Community Facilities District that voted on the measure (being the registered voters then residing in the City of Larkspur and the Town of Corte Madera). As a part of the Rate and Method of Apportionment of Special Tax, the CMPA has allowed for an annual exemption of the special tax in whole or in part. Each year prior to May 31, a new exemption form must submitted to the CMPA. Please note that only households that earned less than the qualifying income limits for very low-income families as established from time to time by the U.S. Department of Housing and Urban Development (HUD), as referenced in Section 50105 of the California Health and Safety Code, may qualify for a Very Low-Income Exemption.

Fiscal Year 2015-2016 Very Low-Income Exemption Application Form

ELIGIBILITY REQUIREMENTS: Only households that earned less than the qualifying income limits for very low-income families as established from time to time by the U.S. Department of Housing and Urban Development (HUD), as referenced in section 50105 of the California Health and Safety Code, may qualify for a very low-income exemption (the attached table identifies the applicable current HUD income limits). The maximum amount of the exemption is \$109, and may be less. If a full or partial exemption is granted pursuant to this very low-income exemption form, it shall be for the 2015-2016 fiscal year special tax levy only. Each year, prior to May 31, a new form must be submitted and approved in order to qualify for a very low-income exemption for the special tax levy for the following fiscal year. Eligibility requirements are subject to annual review and amendment by the police authority and thus may vary from year-to-year.

MERA Announces Senior Homeowner Exemption Applications

A Process for Income Qualified Seniors to Claim an Exemption from MERA's Parcel Tax

Qualified low-income seniors in Marin County are eligible to file for a tax exemption from a parcel tax that supports the County's next-generation emergency radio system.

In November, 2014, Marin County voters approved Measure A, a parcel tax measure to fund the Marin Emergency Radio Authority's Next Generation Public Safety Radio System.

One item included in the measure was the ability of income-qualified senior homeowners to file for an exemption from the parcel tax.

Eligibility:

To qualify for a low-income senior exemption for the Measure A parcel tax for a single-family residence, you must (1) be 65 years of age or older by December 31, 2015, (2) own and occupy your residence, and (3) not have earned a total annual household income of more than **\$62,050** in **2014**.

Deadline:

The deadline to file a low-income senior exemption application for the 2015-2016 tax year is June 1, 2015. The exemption must be renewed annually.
