

**RESOLUTION NO. 17/2022**

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF CORTE MADERA  
(1) ENDORSING THE CORTE MADERA WOMEN’S IMPROVEMENT CLUB GIANT  
INDOOR YARD SALE, AND (2) ALLOWING THREE TEMPORARY SIGNS IN THE  
PUBLIC RIGHT-OF-WAY FROM APRIL 25, 2022 TO MAY 2, 2022 PUBLICIZING  
THE ANNUAL GIANT INDOOR YARD SALE ON APRIL 30, 2022**

**WHEREAS**, on February 17, 2022, the Corte Madera Women’s Improvement Club requested permission to install three banner signs in the public right-of-way from April 25, 2022 to May 2, 2022 Publicizing the Annual Giant Indoor Yard Sale on April 30, 2022; and

**WHEREAS**, the Corte Madera Women’s Improvement Club is a non-profit organization providing a variety of activities and programs for the Corte Madera community; and

**WHEREAS**, the Corte Madera Women’s Improvement Club Giant Indoor Yard Sale raises funds to provide college scholarships to college-bound Larkspur and Corte Madera Redwood High School students who have demonstrated a strong commitment to community service; and

**WHEREAS**, Corte Madera Municipal Code Section 18.22.050(10)(A) permits such signs with the approval of the Town Council.

**NOW, THEREFORE, BE IT RESOLVED**, that the Corte Madera Town Council does hereby endorse the Corte Madera Women’s Club Giant Indoor Yard Sale and approves the request to install three 4’-tall by 7’-wide temporary banner signs as shown in Attachments A and B, subject to the following conditions:

1. The temporary banner signs are permitted to be displayed in the public right-of-way per the Banner Location Program per the following schedule:

April 25, 2022 to May 2, 2022:

- Location #1 – Southeast corner of Corte Madera Avenue and Redwood Avenue
- Location #2 – Madera Boulevard, across from Safeway
- Location #3 – Redwood Hwy., at the East end of Wornum Drive
