5. LIABILITY WAIVER SPECIFIC TO PANDEMIC & COUNTY GUIDELINES

AGREEMENT TO ABIDE BY THE PUBLIC HEALTH OFFICER’S SUMMER CAMP GUIDELINES:

Pursuant to the guidelines established by the Marin County Public Health Officer (<https://marinrecovers.com/summer-camps-youth-activities/>) as they may be amended or updated from time to time children may not move or change from one Childcare Establishment, Summer Camp, or Sports Camp to another more frequently than every 3 weeks.
